By signing this release form, you acknowledge that you are aware of these risks and willingly participate in this event. You promise not to sue the **Southern California Kendo Organization, its officers and board of director, AUSKF, Edison Highschool, the school district** or any other parties associated with the event if you suffer a loss as a result of your participation in this event. If you are the parent or legal guardian of a participating minor, you promise not to sue if he/she suffers a loss as a result of his/her participation in this event. If you do not understand the risks of participating, or if you believe the activity is not within your own ability, or if you feel anything is unsafe, please inform the event staff before participating.

SCKO WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in **2016 SCKO Memorial Day Kendo Tournament**, which is produced and sanctioned by the **Southern California Kendo Organization** the undersigned:

1. Acknowledge and fully understand that each participant is engaging in an activity that involves risk of serious bodily injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence, but the actions, inactions or negligence of others, or from the condition of the premises or of any equipment used. Further, there may be other risks not known to us or not reasonably foreseeable at this time. Each participant assumes all the foregoing risks and accepts personal responsibility for the damages and medical expenses following any such injury, permanent disability or death.
2. Agree that while participating, they will follow all instructions, written and/or oral, provided by event staff, including instructors, safety personnel, and participating vendors. Further, if they believe any activity, equipment or procedure is unsafe, they will immediately report such conditions to the nearest event staff, instructor or vendor, and refuse to participate.

Release, waive, discharge and covenant not to sue the organizers of **Southern California Kendo Organization**, its member clubs and other affiliates, their respective administrators, directors and officers, agents, coaches, and any employees of each organization, other participants, sponsors, advertisers, instructors, as well as participating clubs, organizations and vendors, the **ALL UNITED STATE KENDO FEDERATION**, its member clubs and other affiliates, their respective administrators, directors and officers, agents, coaches, and any employees of each organization, other participants, sponsors, advertisers, instructors, and owners and leasers of premises used to conduct the event, including the **City of Huntington Beach and School District**, all of which are hereinafter referred to as "releasees", from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise.
4. **FOR MINORS:** Agree that as the parent(s) and/or legal guardian(s) of a minor who is participating in this event, I/We will instruct the minor(s) for whom we are responsible to follow all instructions, written and/or oral, provided by event staff, including instructors, safety personnel, and participating vendors. 5. This waiver may not be modified in any way. If any part of this waiver is determined to be invalid by law, all other parts of this waiver shall remain valid and enforceable.
